The PP obtained ToR issued by SEIAA, WB vide No. 1510/EN/T-II-1/006/2020 dated 12.11.2020 against proposal no. SIA/WB/MIS/47616/2019.

SEAC recommended for rejection of the proposed project for Environmental Clearance during its 3<sup>rd</sup> meeting held on 14.06.2023. Based on the certified compliance report of WBPCB, the committee noted that the PP has already installed 2 nos. of Incinerators without obtaining EC, which is a gross violation of EIA Notification, 2006 and its subsequent amendments. Therefore, the SEAC recommended that the present proposal of the PP shall be rejected and the PP shall apply afresh under violation category.

The proponent made online application vide proposal no. **SIA/WB/MIS/300367/2023** dated **17 May 2023** seeking for amendment in EC under the provisions of the EIA Notification, 2006 for the above mentioned proposed project.

SEAC, during its 7<sup>th</sup> meeting held on 12.07.2023, recommended for amendment of EC. SEAC noted that the PP has already applied for expansion of the earlier mentioned EC for construction of additional one tower with incremental total built up area from 149338.35 sqm to 159390.60 sqm. The EC application was appraised in the 1st meeting of SEAC, WB (2023-2026) held on 31.05.2023. After due diligence, the SEAC recommended the proposal for Environmental Clearance. The revised EC conditions for expansion project including the existing one, as approved by SEAC does not mention about existence of any waterbody.

Considering the documents submitted by the PP in the PARIVESH portal along with the EC issued vide No. 1713/EN/T-II-1/064/2017 dated 16.07.2018, the SEAC observed that the land use statement mentioned in the EC does not reflect any waterbody. Hence, the PART – A of the EC – stipulating the Specific Condition (1) Construction Phase – point No. (c) Water body Conservation, may be amended as below :

***Existing water body (if any) should not be lined and their embankments should not be cemented. The water body is to be kept in natural conditions without disturbing the ecological habitat.***

This may be treated as an amendment of the EC issued vide No. 1713/EN/T-II1/064/2017 dated 16.07.2018.
