### **DELIBERATION IN SEIAA**

**SEIAA considered the recommendation of SEAC and decided to ask the following clarifications from the project proponent:-**

- 1. The PP should also upload the copy of paid challan of EC processing fees, details of rainwater harvesting structures, demarcation of area within project site for solid waste management, building permit and sanction plan.**
- 2. As per decision of SEIAA taken in its meeting dated 28.12.2021, the project proponent is required to do tree plantation in at least 40% of the project area (within and outside of project area). Therefore, the PP is requested to submit the revised proposal for compensatory plantation accordingly as stated above.**

**Further, it was also observed by SEIAA that completion certificate for this violation project has been granted by the Uttarpara-Kotrung Municipality vide Memo No. 4/2343 dated 25.06.2019 though the project has neither obtained EC nor having Consent to Operate from WBPCB. SEIAA decided to bring the matter to the notice of Urban Development & Municipal Affairs Dept. to restrain any such issuance of certificate in order to avoid confusion about their legal status.**
