### **INTRODUCTION**

The proponent made online application vide proposal no. SIA/WB/MIN/189700/2020 dated 02.09.2021 seeking environment clearance under the provisions of the EIA Notification, 2006 for the above-mentioned project. The proposed project activity is listed at SL. No. 1(a) Mining of minerals projects under Category "B2" of EIA Notification 2006.

Earlier the project proponent had obtained EC vide No. 2656/EN/T-II-1/048/2013 dated 28.10.2014 for 20033 TPA Black Stone Mining project at Vill – Jamkandar, Mouza – Tarachua, P.S. – Rampurhat, PO – Kastogora, J.L. No. 36, Plot No – 3943(P), 3944, 3945, 3946(P), District- Birbhum, West Bengal.

SEAC recommended for rejection of the EC application based on the following observations :-

- i. The information presented at times were incorrect and confusing. Data/ information in their presentation are grossly incorrect- should be completely revised before presentation under any category of application.
- ii. It was observed that the project proponent has applied for 'Fresh EC' application. However, from documents presented by the project proponent it was noticed that they have a valid EC for existing project. Therefore, it was decided that this application will be recommended for rejection.
- iii. Project proponent may apply for their expansion project through PARIVESH portal.

The project proponent was given opportunity for hearing on 28.02.2022 but the project proponent failed to appear. The PP was given another opportunity for hearing on 17.03.2022 before rejecting their application as per the provisions of EIA Notification, 2006. The project proponent appeared for hearing before SEIAA and accepted their mistake for making faulty application.

#### DELIBERATION IN SEIAA

**It was decided to reject the EC application.**

#### RECOMMENDATIONS OF SEIAA

**The EC application is rejected.**

DELIBERATION IN SEIAA




