

**MINUTES OF THE 10<sup>TH</sup> MEETING OF STATE LEVEL ENVIRONMENT  
IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 10<sup>TH</sup> DECEMBER,  
2020 AT PRANI Sampad Bhavan**

The tenth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 10<sup>th</sup> December, 2020 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5<sup>th</sup> Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

**I. Environmental Clearance.**

1. Application for Environmental Clearance for the Proposed Grain Based Distillery Plant & 4.0 MW Power Plant by **M/s Tandhan Biochemicals Pvt. Ltd.** at JL No.7, Dag No. 18, 18/328, 21, 22, 23, 38, 39, 40, 41, 42, 47, 48, 49, 50, 51, 51/318, 52, 56, 57, 58, 61, 62, 63, 64, 65, 65/317, 66, 67, 69, 70, 71, 72, 73, 75 and 120 of Mouza-Kulepairi, PS-Bagnan, Dist-Howrah, West Bengal. **(SIA/WB/IND2/42446/2018)**

**SEIAA had considered the application for EC in its 76<sup>th</sup> meeting held on 11.02.2020 and had asked the project proponent to submit the certificate for land conversion from 'Shali' to 'Karkhana/Industry' for all plots falling in the project area. Thereafter the project proponent submitted the reply vide their letter No. TBC/WBPCB/EC/P/02 dated 11.11.2020.**

**SEIAA considered the reply and it is observed that the information submitted is incomplete. Therefore, the project proponent is requested to submit complete land documents (ownership, mutation and conversion) for all the plots within the project area. The project proponent is also asked to submit a map showing all the plots within the project boundary.**

**Therefore, the application for EC is deferred (Additional Information).**

2. Application for Environmental Clearance for the proposed residential complex "ALPINE HEIGHTS" by **M/s. Motijug Agencies Ltd., M/s. Modern Gears Pvt. Ltd., M/s. Machine Works (International) Ltd., M/s. Motijug Charitable Trust** at Premises No. 10/4A, Gobinda Chandra Khatik Road, Ward No. 58 of Kolkata Municipal Corporation, Borough – VII, P.S. Tangra, Kolkata – 700 046, West Bengal. **(SIA/WB/NCP/74703/2018)**

**SEIAA considered the recommendation of SEAC and accepted the same.**

**The application for EC is approved based on the KMC Building Permit No. 2019070142 dated 10.02.2020.**



3. Application for Environmental Clearance for the proposed expansion of Residential by **M/s. Broad Tie Up Pvt. Ltd. & Others** at Mouza - Khasmallick, J.L. No. 35, L.R. Dag Nos. 7, 8, 9, 10, 11, 12, 13, 14, 16, 17, 18, 19, 20, 21, 22, 23, 34 & 40, L. R. Khatian Nos.- 1839, 1836, 1838, 1949, 1841/1, 1841, 1852, 1840 & 1837 & Mouza - Hariharpur, J.L. No. 11, L.R. Dag Nos. 85, 86, 87, 88, 89, 90, 92, 93, 95 & 96, L.R. Khatian Nos. - 3727, 3723, 3725, 4149, 3721, 3726, 3722 & 3724, PS - Baruipur, Dist. South 24 Parganas, West Bengal. **(SIA/WB/NCP/71424/2017)**

**SEIAA considered the recommendation of SEAC along with submission made by the project proponent and accepted the same.**

**The application for EC is approved based on the Building Plan No. 514/644/KMDA dated 25.03.2019 and sanctioned by Executive Officer, Baruipur Panchayet Samity vide Memo No. 80/BPS/2018-19 dated 25.03.2019.**

4. Application for Environmental Clearance for the proposed expansion of residential complex by **M/s. PGE Infosolution Pvt. Ltd. and Others** at L.R. Dag Nos. 898, 900; L.R. Khatian Nos. 4382-4421, 4424-4428, 4506 and 4542, Mouza-Mankundu, Holding No. 183/1, Khan Road, P.O. & P.S.-Bhadreshwar, Municipality-Bhadreshwar, J.L. No.-9, Ward No.-20, Dist-Hooghly, Pincode-712136, West Bengal **(SIA/WB/MIS/143877/2020).**

**SEIAA considered the recommendation of SEAC and accepted the same.**

**The application for EC is approved based on the Bhadreswar Municipality Building Permit No. 469/Per dated 14.01.2020.**

## **II. Violation**

1. Application for Environmental Clearance for the construction of Mercantile Building (Shopping Complex) "GENEXX SQUARE" by **M/s Hastera Credit Private Limited** at 37/1, Diamond Harbour Road, J.L. No. - 21, Mouza - Joka, P.S. - Thakurpukur, Under KMC, Kolkata - 700104. **(SIA/WB/MIS/53963/2013).**

**SEIAA considered the recommendation of SEAC and decided that the amount of the Remediation Plan and NCRAP should be fixed @1.5% of the total constructed project cost because the total built up area as per the sanction plan exceeds the built up area mentioned in the stipulated conditions issued on 16.06.2015.**

**SEIAA approved the proposal for Environmental Clearance.**




### III. Miscellaneous


1. Application by **M/s. Orissa Metaliks Pvt. Ltd.** for transfer of part of components in EC issued vide no. 3311/EN/T-IT-I/016/201 dated 3.10.18 to M/s Rashmi Metallurgical Industry Private Limited. **(SIA/WB/IND/131021/2019)**

**SEIAA considered the application and noted that M/s Orissa Metaliks Private Ltd. was issued show-cause notice by MoEF&CC vide letter no. F. No. J-11011/604/2010-IA. II(I) dated 21.09.2020.**


**Under the circumstances it was decided that MoEF&CC would be requested to convey their decision regarding the present status of the case so that the matter may be taken up by SEIAA subsequently.**
