

**MINUTES OF THE 13TH MEETING OF STATE LEVEL ENVIRONMENT
IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 5TH JANUARY, 2021
AT PRANI Sampad Bhavan**

The thirteenth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 5th January, 2021 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

I. CONSIDERATION/RECONSIDERATION OF TOR PROPOSALS

1. Application for Environmental clearance for the proposed residential complex by **M/s RDB REALTY & Infrastructure Limited** at Mouza – Goda, J.L. No. 41, P.S. – Burdwan under Burdwan Municipality, West Bengal. (SIA/WB/NCP/72216/2018).

The project is being dealt under violation category.

SEIAA considered the recommendations of SEAC for issuance of ToR.

SEIAA approved the ToR as recommended by SEAC.

II. ENVIRONMENTAL CLEARANCE

- 1) Application for Environmental Clearance for the proposed project from 90,000 TPA billet (2x12T Induction Furnace) and 1,62,000 TPA wire rods to 1,92,000 TPA wire rods and 60,000 TPA HB wires by adding 1x15T induction furnace by **M/s. Supershakti Metaliks Limited** at Kanjilal Avenue, Tehsil – Durgapur, Dist. – Paschim Bardhaman, West Bengal. (SIA/WB/IND/35205/2018).

SEIAA considered the conditions of SEAC along with the submission made by the project proponent vide their Memo No. SML/SLEIAA/2020-21/01 dated 28.11.2020 in which they have enclosed the provisional permissions from Asansol Durgapur Development Authority for maintaining green space over an area of 2.34 acres for a tenure of three years.

SEIAA accepted the same and approved issue of EC with additional conditions in view of

O.M. of MoEF&CC vide F. No. 22-23/2018-IA.III (Pt) dated 31.10.2019 and F. No. 22-23/2018-IA.III dated 30.12.2019.

- i. **The industry shall meet stack emission standard of 45 mg/Nm³.**
- ii. **Water sprinklers at strategic locations to be installed for controlling fugitive emission from different sources.**
- iii. **The industry shall take up additional tree plantation in approx. 7% of the total land area in consultation with WBPCB.**

- iv. STP of adequate capacity for domestic waste water to be installed as proposed.
- v. Slag to be used for land filling and road construction.
- vi. Monitoring of compliance of EC conditions shall be submitted with third party audit every year.
- vii. The minimum amount of CER shall be 1.5 times of the normal CER.

2) Environmental Clearance for the proposed Residential Complex "IDEAL AURUM" by M/s. **Exult Realty Pvt Ltd.** at Mouza - Kumrakhali, JL No. 48, PS - Sonarpur, Holding No. 116, Sonarpur-Rajpur Municipality, Dist - South 24 Parganas, West Bengal. (SIA/WB/MIS/67289/2017). **Earlier EC No. 2281/EN/T-II-1/061/2013 dated 18.10.2016**

SEIAA considered the recommendation of SEAC and accepted the same.

The application for EC is approved based on the Sonarpur-Rajpur Municipality Building Permit No. 43/Rev/C3/27/27 dated 10.09.2020.

III. MISCELLANEOUS

Review of online status of pending cases on PARIVESH Portal.

The following observations are made:

1. Actual pendency is not reflecting in NIC spreadsheet as well as PARIVESH portal. Total number of pending cases are as follows:
For EC - 55
For ToR - 12
Total - 67 cases are pending but as per the spreadsheet it is showing as 249. It seems that the present status of the balance 182 cases are either yet to be uploaded in the website by SEIAA/SEAC or pending with project proponent for further information.
2. It is observed that there is an overlap of 19 proposals (Annexure-A) between the projects under the head 'Not recommended by SEIAA' and 'Pending of approval for minutes of meeting' as per PARIVESH portal.
3. Three year wise reports (Annexure B, C & D) starting from 1st January, 2018 to 31st December, 2020 were generated from the portal on 05.01.2021 where it is found:






On the same date three different reports were generated from PARI-VESH portal after login by MS, SEIAA, WB. It is observed from the Table-1 that data generated for Total EC/ToR granted under two categories of reports 'Report on sector wise total proposals received, granted/rejected and pending' and 'List of total received, total granted, rejected and total pending proposal report year wise' are not matching. The same mismatch is also observed in case of total pending cases from the two reports. It is further observed that the report mentioning the list of total EC granted is different from the above two reports.

SEIAA seeks clarification from NIC how three different reports are generated from the same data set.

4. It is observed that updation of the status of proposals are not reflecting immediately in the PARIVESH portal.
