

**MINUTES OF THE 2nd MEETING OF STATE LEVEL ENVIRONMENT
IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 16TH JUNE, 2020
AT PRANI SAMPAD BHAVAN**

The second meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 16th June, 2020 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

Miscellaneous

1. Discussion on MoEF&CC's F. No.J-11011/604/2010-IA. II(I) regarding M/s Rashmi Group.

The matter was discussed in detail in view of MoEF&CC's F. No.J-11011/604/2010-IA. II(I) dated 10.06.2020 and its enclosures, it was decided that: -


- a) **Details of all 11 EC applications and 1 ToR application submitted by the project proponent to MoEF&CC and SEIAA, WB would be examined.**
- b) **Project proponent would be asked to submit the boundary demarcation details along with the following maps:-**
 - i. **Satellite imagery map with the name, EC nos., area demarcation with coordinates in respect of all the following projects which obtained EC/ToR from MoEF&CC and SEIAA, WB.**
 - A. **M/s. Rashmi Metaliks Limited.**
 - B. **M/s. Orissa Metaliks Private Limited.**
 - C. **M/s. Orissa Metaliks Private Limited (Unit-I)**
 - D. **M/s. Orissa Metaliks Private Limited (Unit-II)**
 - E. **M/s. Orissa Metaliks Private Limited (1.2 MTPA with 225 MW CPP)**
 - F. **M/s. Orissa Metaliks Private Limited (1.0 MTPA with 225 MW CPP)**
 - G. **M/s. Bansal Cement Limited**
 - ii. **Land use map (Auto-CAD drawing format in scale) for each project showing the road layout, plant layout, tree plantation area along with percentage of total area, boundary coordinates.**
- c) **Land schedule of all the projects mentioning Mouza, Dag No., Plot no. and classification.**
- d) **Summary of ownership details of all the projects which obtained EC/ToR from MoEF&CC and SEIAA, WB.**

- e) Present status of all the projects (A to G).
- f) Latest six-monthly compliance report in respect of each EC.
- g) WBPCB is requested to submit present compliance status of EC conditions in respect of the EC issued by SEIAA, WB.

Therefore, the project proponent is requested to submit the above mentioned documents within a week.

2. Processing of Environmental Clearance applications for projects falling under Item 8 of the Schedule of EIA notification, 2006.

It is noted that many applications are still awaiting the issue of stipulated conditions due to non-submission of required documents by the project proponent or under process by SEAC/SEIAA. In continuation of the decision taken by SEIAA during its 63rd meeting held on 19.09.2019, 65th meeting held on 22.10.2019 and 68th meeting held on 22.11.2019, it is decided that issue of stipulated conditions is no longer required. Therefore, the project proponents who have still not received the stipulated conditions, are requested to withdraw their EC applications online and apply afresh after receiving the sanctioned building plan from the concerned sanctioning authority.
