

**MINUTES OF THE 8TH MEETING OF STATE LEVEL ENVIRONMENT
IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 16TH OCTOBER,
2020 AT PRANI SAMPAD BHAVAN**

The eighth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 16th October, 2020 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB - Block, Sector - III, Salt Lake, Kolkata - 700106. Following cases were discussed:

I. Environmental Clearance.

1. Application for Environmental Clearance for the proposed expansion of residential complex "Flora Fountain" by **M/s. ASPS Developers LLP** at 45, Christopher Road, KMC Ward No-58, Borough-VII, P.S. - Tangra, Kolkata-700046. **(SIA/WB/MIS/79487/2018)**

The SEIAA considered the recommendation of SEAC for issue of EC in view of the KMC sanctioned plan for a total built up area of 62852.04 sqm vide KMC Building Permit No. 2020070003 dated 16.06.2020.

SEIAA approved the proposal for Environmental Clearance.

2. Application for Environmental Clearance for the proposed modification of the construction project 'THE 42' by **M/s. Chowringhee Residency Pvt. Ltd.** at 42B Chowringhee Road, P.S - Shakespeare Sarani, Kolkata - 700071, West Bengal. **(SIA/WB/NCP/76550/2018)**

SEIAA had issued an Environmental Clearance vide Memo No. EN/2087/T-II-1/063/2013 on 19.08.2014 against KMC Building Permit No 2018070281 dated 14.12.2012 for 63614.62 sqm. The project proponent applied for expansion of the project vide above referred application no. against which the stipulated condition was issued on 24.05.2019.

The SEIAA considered the recommendation of SEAC for issue of EC in view of the KMC sanctioned plan for a total built up area of 59431.924 sqm vide KMC Building Permit No. 2018070238 dated 18.01.2019.

This EC will be valid upto a period of 7 years with effect from 19.08.2014 when the original EC was issued.

SEIAA approved the proposal for Environmental Clearance.

3. Application for Environmental Clearance for the proposed expansion of residential project 'The Reserve' by **M/s Tivoli Park Apartments Pvt. Ltd.** at 225, A.J.C. Bose, Kolkata - 700 020. (SIA/WB/MIS/102559/2019)

The SEIAA considered the recommendation of SEAC for issue of EC in view of the KMC sanctioned plan for a total built up area of 51837.27 sqm. vide KMC Building Permit No. 2020080017 dated 18.08.2020.

This EC will be in supersession of the earlier EC issued vide 3008/EN/T-II-1/078/2016 dated 04.09.2018.

SEIAA approved the proposal for Environmental Clearance.

II. Miscellaneous


1. MoEF & CC O.M. F.No.22-65/2017-IA.III dated 30.09.2020 regarding Corporate Environment Responsibility.




The cases where SEAC has already sent their recommendations to SEIAA and are still in the process, SEAC will be requested to send the relevant portion of EMP as mentioned above.

2. Review of online status of applications on PARIVESH portal.
