

**MINUTES OF THE 59TH MEETING OF STATE LEVEL ENVIRONMENT IMPACT
ASSESSMENT AUTHORITY (SEIAA) HELD ON 1ST AUGUST, 2019 AT PRANI SAMPAD
BHAVAN**

The fifty-ninth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 1st August, 2019 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

I. Environmental Clearance

1. Application for Environment Clearance for the proposed expansion of existing Steel Plant by installation of Induction Furnaces (4X15T) and with 1,00,000 TPA capacity Rolling Mill by **M/s Calstar Sponge Limited** at Vill & Mouza-Bamunara, PS-Kanksa, Dist-Pachim Bardhaman, West Bengal. (SIA/WB/IND/34029/2016).

SEIAA considered the recommendation of SEAC and observed that

A) Project proponent is requested to submit the following:

1. Land ownership document.
2. A detailed landscape/plantation plan showing all the species with spacing.
3. Predicted maximum GLC concentration data mentioned in EIA report and page 83 in presentation document is not tallying. A clarification needs to be submitted.

B) WBPCB is requested to submit the following:

1. A note mentioning whether the said project land is falling within the jurisdiction of Durgapur SPA.
2. Compliance report with respect to environmental parameters for the existing plant.

II. Stipulated conditions.

1. Proposed Township and area development project by **M/s. Ideal Riverview Projects Pvt. Ltd** at 39/1, Shalimar Road, P.S-. Shibpur, Ward No. 39, Borough V under Howrah Municipal Corporation, Howrah – 711103, West Bengal. (SIA/WB/NCP/29057/2017).

The SEIAA considered the recommendation of SEAC and approved the stipulated conditions for Environmental Clearance proposed by the SEAC with the following additional conditions:

1. As per the land documents it is observed that several drainage channels (*nallah*) as well one public thoroughfare (*path*) are passing through the project area. A certificate from Howrah Municipal Corporation mentioning any alternatives / NOC is to be submitted along with the sanctioned plan.
2. A detailed landscape/plantation plan showing all the species with spacing is to be submitted.

2. Proposed expansion of residential complex 'The Reserve' by **M/s Tivoli Park Apartments Pvt. Ltd.** at 225B, A.J.C. Bose Road, Kolkata – 700020.

The SEIAA considered the recommendation of SEAC and approved the stipulated conditions for Environmental Clearance proposed by the SEAC with the following additional conditions:

1. A detailed landscape/plantation plan showing all the species with spacing is to be submitted.
2. Provision for car parking for the additional tenements to be clarified.

3. Proposed Residential Complex by **M/s. Smart Vanijya Pvt. Ltd** at Plot Nos. – 1487(P), 1497(P), 1498, 1499(P), 1500(P), 1501, 1502, 1503, 1507, 1508, 1509, 1510, 1511, 1512, 1513, 1514, 1515, 1516(P), 1517(P), at Kadamtala, Khatian No. – 1839, 1840, 1841, 1842, 1843, 1920, 1921, 1922, 1923, 1924, Mouza – Baramohan Singhj, J.L. No. – 71, Atharakhai Gram Panchayat, P.S.- Matigara, Siliguri, Dist. – Darjeeling, West Bengal. (SIA/WB/NCP/75755/2018).


The SEIAA considered the submission made by the project proponent and observed the following:


1. The additional green area was previously shown as car parking area. Detailed conceptual plan showing MLCP and open car parking area to be submitted.
2. The landscape plan which is submitted is not legible and appropriate. A detailed composition of species with spacing in a bigger scale drawing to be submitted. In the plan only outline of the building profile should be shown with other amenities and services.


III. Miscellaneous
