

**MINUTES OF THE 55TH MEETING OF STATE LEVEL ENVIRONMENT IMPACT
ASSESSMENT AUTHORITY (SEIAA) HELD ON 12TH JUNE, 2019 IN THE DEPARTMENT
OF ENVIRONMENT, PRANISAMPAD BHAVAN.**

The fifty-fifth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 12th June, 2019 in the Department of Environment, Pranisampad Bhavan, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

I. Cases for Hearing

1. Request for changes in the Environmental Clearance (EC) issued vide no. 358/EN/T-II-1/063/2016 dated 21.02.2019 for the proposed expansion of the residential complex (Phase 2) by **M/s. Riya Manbhari Projects LLP** at Howrah Amta Road, RS Dag No.5844, 5845, 5848, 5849, 5850, 5851, 5852/7511(P), LR Dag. No. 7345, 7346, 7349, 7350, 7351, 7352, 7377, LR Khatian No 8219, 8226, 8218, 8225, 8267, 8268, 8341, 8342, 8343, 8349, 8545, 8546, 8547, 8549, 8550, 8551, 8552, 8553, 8554, 8555, 8640, 8641, 8642, 8643, 8644, 8649, 8650, 8651, 8694, 8695, 8696, 8711, 8712, 8713, 9302, Mouza – Domjur, & RS Dag No. 1657, 1658, 1659, 1660, 1661, 1662, 1670, LR Dag No. 1768, 1769, 1770, 1771, 1772, 1773, 1774, LR Khatian No. 3597, 3598, 3599, 3605, 4231, 4233, 4389, 4390 in Mouza – Makardah and RS Dag No. 22, 23, 29, 30, 37(P), 38, 39, 40, LR Dag Nos. 22, 23, 29, 30, 37(P), 38, 39, 40, LR Khatian No. 1448, 1449, 1450, 1451, 1456, 1458, 1576, 1577, 1580, 1584, 1600, 1610, 1611, 1612, 1613, 1614, 1617, 1618, 1620, 1640, 1757, 1802 in Mouza – Pubannapara, P.S. The project proponent appeared for the hearing and admitted that erroneous documents were submitted inadvertently from their end. The SEIAA decided to cancel the Environmental Clearance already issued vide no. 358/EN/T-II-1/063/2016 dated 21.02.2019.

The project proponent may submit rectified documents along with copy of sanctioned building plan to the SEAC for fresh appraisal.

II. Cases for Final Environmental Clearance

1. Application for Environmental Clearance for the proposed China Clay and Fire Clay Mines at Vill – Mokdannagar & Tentulberia, P.S.- Mohammad Bazar, Dist – Birbhum, West Bengal by **M/s. West Bengal Mineral Development & Trading Corporation Ltd.** (SIA/WB/MIN/30499/2017)

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

2. Application for Environmental Clearance for the Proposed expansion project from 90,000 TPA billet (2 X 12T Induction Furnace) and 1,62,000 TPA wire rods to 1,92,000 TPA wire rods and 60,000 TPA HB wires by adding 1 X 15T induction furnace by **M/s Supershakti Metaliks Ltd.** at Kanjilal Avenue, Tehsil-Durgapur, Dist.-Paschim Bardhaman, West Bengal. (SIA/WB/IND/35205/2018)

The Authority considered the recommendation of SEAC and decided that the project proponent to submit the Plantation plan mentioning the species and plantation pattern along with dimensions of all plantation areas both within the premises and outside in the adjacent land being provided by Durgapur Municipal Corporation.

3. Application for Environmental Clearance for the Proposed Shopping Complex "Genexx Square" by **M/s. Hastera Credit Pvt. Ltd** at Diamond Harbour Road, J.L. No. - 21, Mouza - Joka, PS - Thakurpukur, Kolkata-700104.

The Authority considered the recommendation of SEAC and decided that the project proponent should submit the following certificates:

- i. **Existing built up area and height by the project architect.**
 - ii. **Structural stability of the existing structure by the Structural Engineer.**
4. Application for Environmental Clearance for the Proposed Residential Complex by **M/s. Swadha Nirman Pvt. Ltd. & Ors.** at Holding No. 1048, Kutul Sahi Road, Ward No. 29 under Barasat Municipality and Holding No. 233 Badu Road, Ward No. 12 under Madhyamgram Municipality, PS - Barasat, Dist.- North 24 Parganas, West Bengal. (SIA/WB/NCP/76050/2018)

The Authority considered the recommendation of SEAC, additional documents submitted by the project proponent vide Memo No. Nil dated 17.05.2019 and Memo No. Nil dated 10.06.2019 and approved the proposal for Environmental Clearance with reference to the sanctioned Serial No. 1189 dated 09.02.2018 of Barasat Municipality and P/A No.1450/MM/2016-2017 dated 16.02.2016 of Madhyamgram Municipality.

5. Application for Environmental Clearance for the Proposed Complex by **M/s. Shah Projects Pvt. Ltd. & Ors.** at 37, Chanditala Main Road , KMC Ward No. 116, Borough No. XIII, Mouza-Siriti, J.L. No. 11, R.S. Dag No. 81, 82, 114, 81/1092 & 113/528, R.S. Khatian No. 566, 586,& 344, P.S.-Behala, Kolkata-700053, West Bengal.

The Authority considered the sanctioned plan vide KMC Building Permit No. 2018130340 dated 28.03.2019 submitted by the project proponent and it was observed that the Tree Covered Area is mentioned as 2272.785 sq.m. (16.454% of land area) whereas the project proponent had earlier submitted that the Exclusive Tree Plantation area would be 2915.21 sq.m. (21.10% of land area). Therefore, the project proponent is asked to submit the necessary clarification for the said discrepancy.

6. Application for Environmental Clearance for the Proposed Residential Complex by **M/s. Akshay Vinimay LLP** at 12B, Beliaghata Main Road, under KMC Ward No. 57, Borough - VII, P.O. - C.I.T. Road, PS - Entally, Kolkata - 700 015, West Bengal.

The Authority considered the recommendation of SEAC, additional documents submitted by the project proponent vide Memo No. Nil dated 03.06.2019 which includes letter of KMC No.01/XXB/057/16-17 dated 06.04.2019 and approved the proposal for Environmental Clearance with reference to the sanctioned vide Building Permit No. 2018070231 dated 10.01.2019.

III. Stipulated Conditions

1. Proposed Residential Complex by **M/s Merlin Projects Limited** at R.S./L.R. Dag No. – (442, 443, 444, 447, 453, 454), J.L. No. 29 of Khamar Mouza & R.S./L.R. Dag No. – [199(P), 101, 102, 103, 105, 106, 107, 108, 109, 110, 111, 112, 113(P), 114(P), 115, 125, 126, 127, 128, 141, 142, 143, 144, 185, 186, 187, 188, 85(P), 680, 686, 687, 688, 689], J.L. No. 44 of Bishnupur Mouza under Rajrhat Bishnupur II No. Gram Panchayat, PS – Rajarhat, Dist. – North 24 Parganas, West Bengal. (SIA/WB/MIS/35854/2019)

The Authority considered the recommendation of SEAC and approved the stipulated conditions for Environmental Clearance proposed by the SEAC.

The project proponent has proposed a 3.5 m. wide public road to access the land locked parcel (not belonging to the project proponent) falling within the proposed project. The said road should be formally handed over to the local body and their acceptance for using it as public road to be submitted by the project proponent along with sanctioned plan.

2. Proposed commercial-cum-IT/ITES & Mixed use development by **M/s P.C. Chanda & Company (P) Limited** at Holding No. C6-108/New, J.L. No. 1, Mouza – Gopalpur, B.B.T. Road No. R.H.S. towards Kolkata, Ward No.12, Dist – South 24 Parganas, Under Maheshtala Municipality, Kolkata-700088, West Bengal. (SIA/WB/NCP/87142/2018)

The SEIAA considered the recommendation of SEAC and approved the stipulated conditions for Environmental Clearance proposed by the SEAC with the additional condition that the project proponent to submit the plantation plan mentioning the species and plantation pattern along with dimensions of all plantation areas within the premises.

IV. Miscellaneous

1. Request for **Change of name** of project proponent from **M/s OCL India Limited** to **M/s Dalmia Cement (Bharat) Limited** in EC vide no. 2589/EN/T-II-1/061/2016 dated 28.11.2017. (SIA/WB/IND/20121/2016).

The SEIAA considered the submission of M/s. Dalmia Cement (Bharat) Limited vide No. DCBL/Merger/EC/01/2018-19 dated 20.05.2019 and approved the change the name of project proponent from 'M/s. OCL India Limited' to 'M/s Dalmia Cement (Bharat) Limited' for EC issued vide No. 2589/EN/T-II-1/061/2016 dated 28.11.2017.
