

MINUTES OF THE 06TH MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 18TH MAY, 2017 AT PARIBESH BHAVAN

The sixth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 18th May, 2017 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector - III, Salt Lake, Kolkata-700098. Following cases were discussed:

I. Cases for Final Environmental Clearance

- 1. Environmental clearance application for the proposed expansion of cement grinding unit for installation of additional 1x400 TPD ball mill at dag no. 1083, JL. No. 244, P.O. Kanchanpur, P.S. Bankura, Dist. Bankura, West Bengal by M/s. Vigneshwara Cement Pvt. Ltd.**

In view of the compliance of conditions mentioned by SEIAA vide Memo No. 634/EN/T-II-1/080/2014 dated 28.03.2017 by the project proponent and considering the recommendation of the SEAC, the Authority considered and approved the proposal for Environmental Clearance.

- 2. Environmental Clearance application for the proposed expansion of Hospital (2nd Phase) at Diamond Harbour Road (near Joka), Village - Sarmaster Chawk, Khatian No. LR 316, JL No. 17, P.O. Pailan, Kolkata - 700 104, Dist. South 24 Parganas, West Bengal by M/s. Bharat Sevashram Sangha Hospital.**

Compliance of points mentioned in the letter No. 266-2N-15/2012(E) dated 10.05.2012 issued by SEAC to be checked with the sanctioned plan and other relevant documents submitted vide Ref. No. BSSH/O/16/030 dated 02.12.2016 by SEAC.

- 3. Environmental Clearance application for the proposed Cement Grinding Unit of capacity 5 MTPA and CPP of capacity 20 MW at Village - Parbatpur & Digha, Tehsil - Raghunathpur, Dist. - Purulia, West Bengal by M/s. Shree Cement Ltd.**

The Authority considered the recommendation as well as the conditions proposed by SEAC and approved the proposal for Environmental Clearance on submission of the original EIA Report duly signed by the accredited consultant.

II. Stipulated Conditions

- 1. Environmental Clearance application for the proposed residential complex at 12 B, Beliaghata Main Road, Ward No. 57, Borough VII of KMC P.O. CIT Road, P.S. Entally, Kolkata - 700 015 by M/s. Akshay Vinimay Pvt. Ltd. - Submission of tree felling permission.**

The SEIAA examined the documents submitted by the project proponent as well as the recommendation of SEAC and decided that the project proponent should submit the following :-

- i. The soft copies of all the drawings of the proposal in AutoCAD format showing the relevant portions in polyline to SEIAA.
- ii. Plan showing the positions of STP and rainwater harvesting system including storage tank(s).
- iii. Detailed sections of the STP and rain water harvesting system.
- iv. List showing size and category of tenements.
- v. Copy of Mutation Certificate.

2. Environmental Clearance application for the proposed residential complex "The Reserve" at 225B, A.J.C Bose Road, Kolkata-700019 by M/s. Tivoli Park Apartments Pvt. Ltd.

The SEIAA examined the documents submitted by the project proponent as well as the recommendation of SEAC and decided that the project proponent should submit the following :-

- i. The soft copies of all the drawings of the proposal in AutoCAD format showing the relevant portions in polyline to SEIAA.
- ii. Plan showing the positions of STP and rainwater harvesting system including storage tank(s).
- iii. Detailed sections of the STP and rain water harvesting system.
- iv. List showing size and category of tenements.
- v. Copy of Mutation Certificate.

3. Environmental Clearance application for the proposed housing complex at Mouza - Sukhchar, JL. No. 9, 518, B.T. Road, PS - Khardah, Dist. North 24 Parganas, under Panihati Municipality Ward No. 14, Holding No. 1, Kolkata - 700 115, West Bengal by M/s. Inka Infrastructure Pvt. Ltd. & 3 Ors.

The SEIAA examined the documents submitted by the project proponent as well as the recommendation of SEAC and decided that the project proponent should submit the following :-

- i. The soft copies of all the drawings of the proposal in AutoCAD format showing the relevant portions in polyline to SEIAA.
- ii. Plan showing the positions of STP and rainwater harvesting system including storage tank(s).
- iii. Detailed sections of the STP and rain water harvesting system.
- iv. List showing size and category of tenements.
- v. Copies of Land Deed and Mutation Certificate.

III. Miscellaneous

1. Amendment of environmental clearance application for the proposal for setting up a chemical / bulk drug manufacturing unit on lease at SL area in Durgapur, Burdwan, West Bengal by M/s. West Bengal Chemical Industries Ltd.

SEIAA examined the submission of the project proponent dated 09.03.2017 and decided that the case may be appraised by SEAC.

2. Environmental clearance application for the proposed construction of Phase II of "Chaitanya Chandrodaya Mandir and Indian Educational and Cultural Centre" at Sri Mayapur, Dist. Nadia by ISKON.

SEIAA considered the observation of SEAC and noted that the project proponent has initiated the construction activities without obtaining Environmental Clearance. This is a case of violation of EIA Notification, 2006 and its amendments.


As per MoEF & CC Notification No. S.O.804 (E) dated 14.03.2017 it was decided that the project proponent is directed to apply for Environmental Clearance to the MoEF & CC within six months from the date of the aforesaid notification.


3. **Change of name - Environmental Clearance application for the proposed expansion project for the manufacture of 4,36,500 TPA billets by installation of 6X25 Ton Induction Furnaces, 2X30 Ton Ladle Refining Furnaces, 2 nos. 6/11, 3 strand Continuous Billet Caster at Sagarbhangra, Vill - Gopinathpur, Durgapur, Dist - Burdwan, West Bengal by M/s. SRMB Srijan Ltd.**


SEIAA considered the submission of the project proponent and agreed to change the name of the project proponent from 'SRMB SRIJAN LIMITED' to 'SRMB SRIJAN PRIVATE LIMITED' in the Environmental Clearance issued vide No. 764/EN/T-II-1/031/2014 dated 12.04.2017.

4. **Regarding trees to be planted - Environmental clearance for the proposed Residential Complex at 158A, Picnic Garden Road, KMC Ward No. 66, Kolkata - 700 039 West Bengal by M/s. Metflow Corporation Pvt. Ltd., Wellmet (Calcutta) Pvt. Ltd.**

SEIAA considered the submission made by the project proponent and decided that the DFO utilization division may be approached for reassessment of the entire tree cutting and plantation plan.
