

**MINUTES OF THE 10TH MEETING OF STATE LEVEL ENVIRONMENT IMPACT
ASSESSMENT AUTHORITY (SEIAA) HELD ON 21ST JUNE, 2017 AT PARIBESH BHAVAN**

The tenth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 21st June, 2017 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector - III, Salt Lake, Kolkata-700106. Following cases were discussed:

I. Cases for Final Environmental Clearance

- 1. Environmental clearance application for the proposed Residential Complex "Tolly Towers" at 3, Netaji Subhas Chandra Bose Road, KMC Ward No. 97, PS - Regent Park, Kolkata - 700 040 by M/s. Tollygunge Estates Pvt. Ltd.**

The Authority examined the recommendation as well as the conditions proposed by SEAC and decided to request the project proponent to submit a detailed drawing mentioning all dimensions and functional, positional arrangement of STP and rainwater harvesting reservoir. Further the project proponent should mention the type (aerobic / anaerobic) of STP and its working principle considering the locational details.

- 2. Environmental Clearance application for the proposed Common Biomedical Waste Treatment Facility at Dag No. 479 & 470, Block - Polba-Dadpur, Dist - Hooghly, West Bengal by M/s. Medicare Environmental Management Pvt. Ltd.**

The Authority considered the recommendation of SEAC as well as submission of the project proponent and approved the proposal for Environmental Clearance with the following additional conditions -

1. The project proponent should plant minimum of three rows of trees all around the periphery of the plant.

II. Stipulated Conditions

- 1. Environmental Clearance application for the proposed residential complex at Beliaghata Main Road, Ward No. 57, Borough VII of KMC PO - CIT Road, PS - Entally, Kolkata - 700 015 by M/s. Akshay Vinimay Pvt. Ltd.**


The SEIAA approved the stipulated conditions proposed by SEAC. It was further decided that the project proponent will :

- 1) Incorporate details of all dimensions and functional, positional arrangement of STP and rainwater harvesting reservoir in the approved plan. Further the project proponent should mention the type (aerobic / anaerobic) of STP and its working principle considering the locational details.
- 2) Submit site plan showing Land use distribution with polyline and corresponding legend mentioning Area and Percentage of each use both in soft (Auto CAD 2010) & hard copy formats.
- 3) Submit document from any statutory authority showing classification of land of the proposed project.


2. Environmental Clearance application for the proposed Housing Complex at Mouza - Sukhchar, JL No. 9, 518, B. T. Road, Ps - Khardah, Dist - North 24 Parganas, under Panihati Municipality Ward No. 14, Holding No.1, Kolkata 700 115, West Bengal by M/s. Inka Infrastructure Pvt. Ltd. & Ors.

The SEIAA approved the stipulated conditions proposed by SEAC. It was further decided that the project proponent will :


