

**MINUTES OF THE 15<sup>TH</sup> MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 24<sup>TH</sup> AUGUST, 2017 AT PARIBESH BHAVAN**

The fifteenth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 24<sup>th</sup> August, 2017 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector – III, Salt Lake, Kolkata-700106. Following cases were discussed:

**I. Cases for Final Environmental Clearance**

**1. Application for Environmental Clearance for the proposed expansion of Cement Grinding Unit from 2.4 to 3.6 MTPA and 2x18 MW CPP at Vill – Salboni, Dist. Paschim Medinipur, West Bengal by M/s. JSW Cement Ltd.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance with the following additional condition:

The unit shall install Continuous Automatic Ambient Air Quality Monitoring Station (CAAAQMS) for the project.

**2. Application for Environmental Clearance for the proposed expansion involving enhancement in Cement production capacity (2.0 MTPA to 2.4 MTPA) by installation of new Slag Grinder in existing Standalone Cement Grinding Unit at JL No. 80, Vill. & Mouza – Panchgarha, PS – Chanditala, Dist, Hooghly, West Bengal by M/s. Ultratech Cement Ltd.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance with the following additional condition:

The unit shall install Continuous Automatic Ambient Air Quality Monitoring Station (CAAAQMS) for the project.

**3. Application for Environmental Clearance for the proposed Saharjora Fire Clay Mine at Vill. Saharjora, Tehsil : Barjora, P.O. Mukatore, Dist. Bankura, West Bengal by Shri Jitendranath Banerjee.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

**4. Application for Environmental Clearance for the proposed Residential cum Commercial Complex at 49/39, Jessore Road East, Block – Barasat I, Mouza – Siti, JL. No. 101, P.O. + PS. – Barasat, Barasat Municipality Ward No. 01, Dist. North 24 Parganas, West Bengal by M/s. Candice Towers Pvt. Ltd. & Others.**

The Authority examined the additional documents submitted by the project proponent. It was noted that the submitted documents are not in conformity with the specific clarifications sought for. Therefore the project proponent may be asked to resubmit the required documents as mentioned in the letter no. 1486/EN/T-II-1/078/2015 dated 17.07.2017 of SEIAA.

- 3) The microclimatic study of the project area delineating the exclusive tree plantation area ensuring that the plantation area does not fall under shadow zone.






