

**MINUTES OF THE 42<sup>ND</sup> MEETING OF STATE LEVEL ENVIRONMENT IMPACT  
ASSESSMENT AUTHORITY (SEIAA) HELD ON 28<sup>TH</sup> NOVEMBER, 2018 AT  
PRANI Sampad Bhavan**

The forty-second meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 28<sup>th</sup> November, 2018 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5<sup>th</sup> Floor, LB - Block, Sector - III, Salt Lake, Kol-106. Following cases were discussed:

**I. Cases for Final Environmental Clearance**

1. Application for Environmental Clearance for proposed installation of a manufacturing unit of Synthetic Resin (2050 TPA) and Paint (4.0 Lakh Liter/annum) at J.I. no. 74, Dag No. RS-3799(old), RS(Hal) 3103, Khatian No. 2148, Vill. Narayanpur, P.O. - B - Narayanpur, P.S. Bhangar, Dist. South 24 Parganas, West Bengal by M/s. Ashhad Paints and Resin Mfg.

**The Authority considered the recommendation of SEAC. However, following observations are made:**

- i. **The Executive Summary submitted by the project proponent is not commensurate with the requirements mentioned in the ToR issued on 28.11.2017.**
- ii. **It is found that the land status mentioned in the *porcha* as 'Pukur Paar' as submitted by the project proponent. Thus the proposal should be in compliance with the clause No. 17A of Chapter IIIA of the West Bengal Inland Fisheries Act, 1984.**
- iii. **A schematic layout / flow diagram of the industrial unit has been submitted by the project proponent, which is not sufficient. Scaled layout maps indicating storage area, plant area, greenbelt area, utilities, road network, water reservoir, detailed layout of the machineries inside the plant to be submitted.**

**The proposal is, therefore, required to be reappraised by SEAC.**

2. Application for Environmental Clearance for the proposed residential complex on Holding no. 449/A, G.T. Road - Lot-3 (449/A/2, G.T. Road), J.L. No. 15, L.R. Kharian No. 11331, Dag No. 4333, 4376, 4379, 4332, 4317, 4378, Mouza - Mahesh, Serampore, Dist. Hooghly, West Bengal by M/s. Happy Niketan Private Limited.

**The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.**

**II. Miscellaneous**



**Application for withdrawal submitted vide No. Nil dated 01.11.2018 has been allowed on 15.11.2018 which is ratified.**

4. Application made by Project Proponents to reduce CSR amount in light of the O.M. vide F No. 22-65/2017-IA.III dated 01.05.2018 issued by MoEF&CC.

**Some project proponents have approached SEIAA for amendment of the Environmental Clearance for revision of CSR/CER amount based on the above O.M.**

**SEIAA decided that in all such cases where the Environmental Clearance has been issued on or after 01.05.2018, the CSR/CER amount would be revised in accordance with the above O.M.**
