

**MINUTES OF THE 12TH MEETING OF STATE LEVEL ENVIRONMENT
IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 24TH DECEMBER, 2020
AT PRANI Sampad Bhavan**

The twelfth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 24th December, 2020 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB - Block, Sector - III, Salt Lake, Kolkata - 700106. Following cases were discussed:

I. Terms of Reference.

1. Application for Environmental Clearance for the proposed installation of 2 x 20 Tonnes Induction furnaces with Continuous Caster and 1, 48, 800 MT/Annum Rolling Mill in addition to existing facilities by **M/s Shree Ramdoot Rollers Pvt. Ltd.** at Vill & Mouza - Nidhirampur, PS-Gangajalghati, JL No. 034, Khatian No. 1196, Dist-Bankura, PIN - 722133, West Bengal. (SIA/WB/IND/31555/2019)

ToR given by SEAC on 06.05.2019 is hereby approved.

II. Environmental Clearance.

1. Application for Environment Clearance for the proposed hospital building by **M/s. Belle Vue Clinic** at plot no. DG-14 in AA-ID, premises no. 08-0327, JL No. 24, Mouza-Jatragachi, New Town, dist 24 Pgs(N), West Bengal. (SIA/WB/NCP/55712/2016).

In the meeting held on 11.02.2020 SEIAA noted that the total built up area as mentioned (30346.27 sqm.) was not tallying with the area mentioned in the sanctioned building plan and permit issued by NKDA. SEIAA asked the project proponent for clarification.

The project proponent submitted the reply in which they have submitted a statement showing the breakup of the built up area (29552.857 sqm.), which is again not tallying with the earlier submission made by the project proponent. The project proponent is requested to get the total built up area certified in the sanctioned plan and building permit by the sanctioning authority.

Therefore, the application for EC is deferred (Additional Information).

2. Application for Environmental Clearance for the proposed Establishment of Common Biomedical Waste Treatment Facility by **M/s. RVD Waste Tech Pvt. Ltd.** at Plot No. 125 and 128, Mouza - Khirgram, Block - Mongalkote, Sub-division: Katwa, District: Purba Bardhaman, West Bengal. (SIA/WB/MIS/52197/2018)

SEIAA considered the reply submitted by the project proponent along with the N.O.Cs from Health & Family Welfare Dept., Govt. of West Bengal vide No. 219-HS(MS)/HFW-15099/16/2020 dated 23.11.2020

and West Bengal Pollution Control Board (WBPCB) vide letter No. 352-2N-05/2019(E) dated 11.11.2020 and accepted the same.

The application for EC is approved.

3. Application for Environmental Clearance for the proposed residential cum commercial complex by **M/s. Ambey Realtors LLP** at Dag No. 199, 205, 218, 227, 232-236, 248-254, Khatian no. 1276, 1274, 1537-1549, 1581, 1824, 1825, 1844, 1863, 1892-1894, 1899-1902, 2293, 2311, 2452, Mouza - Atghara, J.L. No. 10, Biswa Bangla Sarani, Chinar Park, Kolkata - 700 136, Ward No. 12, Bidhannagar Municipal Corporation, P.O. Rajarhat Gopalpur, P.S. Baguihati, Dist North 24 Parganas, West Bengal. (SIA/WB/NCP/58991/2016)

SEIAA considered the recommendation of SEAC and accepted the same.

The application for EC is approved based on the BMC Building Permit No. BMC/BPN/RG/352/80/1718(3/11) dated 16.10.2019.

4. Application for Environmental Clearance for the proposed installation of 2 x 20 Tonnes Induction furnaces with Continuous Caster and 1, 48, 800 MT/Annum Rolling Mill in addition to existing facilities by **M/s Shree Ramdoot Rollers Pvt. Ltd.** at Vill & Mouza - Nidhirampur, PS-Gangajalghati, JL No. 034, Khatian No. 1196, Dist-Bankura, PIN - 722133, West Bengal. (SIA/WB/IND/56059/2019)

SEIAA considered the recommendation of SEAC and observed the following:

- i. The plant is an existing unit with the consent from WBPCB. Thus, a field inspection by WBPCB is required to be done to know the compliance status.
- ii. The applicant has not submitted the necessary permission from SWID for extraction of ground water for the entire project.
- iii. A map showing the boundary of the project area (existing and proposed) with all the Dag Nos. is required to be submitted.
- iv. In the Sale Deed vide item no. LXIV on pg. no. 22 it is found that a 'doba' measuring around 7 decimals is present within the project area. The project proponent is directed not to fill up the water body nor relocate the same without necessary permission from the competent authority.
- v. It is observed that the project site appears to be close to elephant migratory route. The project proponent is, therefore, requested to obtain a N.O.C. from the Chief Wildlife Warden, West Bengal.

Accordingly, WBPCB and the project proponent are requested to take necessary action.

Therefore, the application for EC is deferred (Additional Information).

5. Application for Environmental Clearance for the proposed residential complex by **M/s. A & J Main & Co. (Engineers) Pvt. Ltd.** at premises no. 151, Andul Road, J.L. No. 1, Mouza - Shibpur, Ward No. 38 of Howrah Municipal Corporation, Touzi No. 798, RS Dag No. 1994, L.R. Dag No. 78, 79 & 80, L.R. Khatian No. 23, PS - Shibpur, West Bengal. **(SIA/WB/MIS/109511/2019)**

SEIAA considered the recommendation of SEAC and accepted the same.

The application for EC is approved based on the Howrah Municipal Corporation Building Permit No. 1641/18-19 dated 21.09.2020.

III. Violation

1. Application for Environmental Clearance for the proposed multi-storeyed housing complex 'Akanksha' by **New Town Construction Division-II, Housing Directorate** at Plot No. DB-2, premises no. 07-0300, Action Area ID, Newtown, Rajarhat, Kolkata **(SIA/WB/MIS/49324/2017)**.



Therefore, the project proponent is directed to submit the same.


The application for EC is deferred (Additional Information).


III. Miscellaneous
