## MINUTES OF THE 19<sup>TH</sup> MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 14<sup>TH</sup> NOVEMBER, 2017 AT PARIBESH BHAVAN

The nineteenth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 14th November, 2017 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector – III, Salt Lake, Kolkata-700106. Following cases were discussed:

## I. Cases for Final Environmental Clearance

 Application for Environmental Clearance for the proposed housing complex at 34, Diamond Harbour Road, Kolkata -700 027, West Bengal by M/s. DSK Real Estates Ltd.

SEIAA examined the documents submitted by the project proponent. It is found that the detailed plan and sectional drawings of the STP, compost plant and rainwater harvesting reservoir are not in order and need to be submitted after incorporating the necessary details.

 Application for Environmental Clearance for the proposed residential complex "Jiva" at 6, Pagladanga Road, Ward No. 57 of KMC, Borough VII, Kolkata – 700 015, West Bengal by M/s. Emporis Properties Pvt. Ltd.

The Authority considered the recommendation of SEAC, the submissions made by the project proponent and approved the proposal for Environmental Clearance.

3. Application for Environmental Clearance for the proposed expansion involving enhancement in cement production capacity (0.95 MTPA to 2.0 MTPA - PPC/OPC/PSC) by installation of Vertical Roller Mill in the existing standalone cement grinding unit at Village - Rakshachak, Anchal- Amalhanda, Tehsil - Kolaghat, Dist. Purba Medinipur, West Bengal by M/s. The Ramco Cements Ltd.

The Authority considered the recommendation of SEAC, the submissions made by the project proponent and approved the proposal for Environmental Clearance.

4. Application for Environmental Clearance for the proposed expansion of the existing cement grinding unit from 1.35 MTPA to 4.0 MTPA through optimization of the existing cement grinding unit and by installation of a new 2.25 MTPA cement grinding unit in the existing premises at Village - Kalapachuria, P.O. Godapiasal, P.S. Salboni, District - Paschim Medinipur, West Bengal by M/s. OCL India Ltd.

The Authority considered the recommendation of SEAC, the submissions made by the project proponent and approved the proposal for Environmental Clearance.

 Application for Environmental clearance for the proposed residential complex at LR dag nos. 1581-1584, 1586, 1587, 1492 & 1493, Mouza - Mahammadpur, JL. No. 32, P.S. Rajarhat, Rajarhat-Bishnupur 2 no. Gram Panchayat, Dist. North 24 Parganas, West Bengal by M/s. Realtech Nirman Pvt. Ltd.

The Authority examined the recommendation of SEAC. The project proponent is requested to:

 Incorporate details of all dimensions and functional, positional arrangement of STP, compost plant and rainwater harvesting reservoir in the plan. Submit final site plan (in conformity with the final approved plan) showing Land use distribution with polyline and corresponding legend mentioning Area and Percentage of each use both in soft (Auto CAD 2010) & hard copy formats.

## II. Miscellaneous

1. Application for Environmental Clearance for the proposed rehabilitation cum restructuring of existing M/s. Hooghly Dock and Port Engineers Ltd. by M/s. Cochin Shipyard Ltd.

The matter is referred to the Department of Environment for necessary action from their end.

2. Amendment - Application for Environmental Clearance for the Proposed Nonrecovery Type Coke Oven Plant of capacity 1,20,000 TPA at J.L No.115, Mouza- Amba, Vill-Gokulpur, P.O: Samraipur, Kharagpur, Dist. - Paschim Medinipur, Pin- 721301, West Bengal by M/s. Metalik Fuel Private Limited (formerly M/s GSA Commercial Pvt. Limited.)

SEIAA considered the recommendation of SEAC and decided that the project proponent should duly apply for environmental clearance for proposed enhancement of production capacity.

3. Extension of validity - Application for Environmental Clearance for the proposed Residential cum commercial Complex at 39, G.T. Road, Champdani, Mouza - Gourhati, P.S. Chandannagar, Chandannagar Municipal Corporation Ward No. 27, Dist. Hooghly by M/s. Northbrook Jute Company Limited.

SEIAA examined the application of the project proponent dated 26.09.2017. In light of S.O.2944(E) dated 14.09.2016 of MoEF & CC, SEIAA decided that the extension of validity of environmental clearance can not be granted as the application for such extension was made beyond the expiry of 90 days from the expiry of the validity of the existing EC issued vide Memo No. EN/2095/T-II-I/012/2007 dated 25.09.2008.

4. Prayer to withdraw - Environmental Clearance application for the proposed shipping container freight station along with truck terminals "INFRA LOGISTIC PARK" at Plot No. - 3239/4010 & 3239/4031, Jl. No. - 153, Mouza Chakdeepa, PS – Bhawanipur, Haldia, Dist – Purba Medinipur, West Bengal by M/s. Apcejay Infralogistics Pvt. Ltd.

SEIAA considered the recommendation of SEAC and the letter no. nil dated 30.06.2017 of the project proponent mentioning that the construction and sanction for the project is less than 20,000 sq.m. Therefore, SEIAA approved withdrawal of the application for environmental clearance.
