

**MINUTES OF THE 21ST MEETING OF STATE LEVEL ENVIRONMENT IMPACT
ASSESSMENT AUTHORITY (SEIAA) HELD ON 23RD NOVEMBER, 2017 AT PARIBESH
BHAVAN**

The twenty first meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 23rd November, 2017 in the Conference Room of the Department of Environment, Pranisampad Bhawan, 5th floor, LB2, Sector - III, Salt Lake, Kol-106. Following cases were discussed:

I. Cases for Final Environmental Clearance

- 1. Application for Environmental Clearance for the proposed housing complex at 34, Diamond Harbour Road, Kolkata - 700 027, West Bengal by M/s DSK Real Estates Ltd.**

The Authority considered the recommendation of SEAC, the submissions made by the project proponent and approved the proposal for Environmental Clearance.

- 2. Application for Environmental Clearance the proposed housing complex "THE 101" at Mouza - Sarmestarchak, J.L. No. 17 & Mouza - Daulatpur, J.L. No. 79, P.O. Pailan Hat, P.S. Bishnupur, Dist. - South 24 Parganas, West Bengal by M/s. P.S. Vinayak Complex LLP.**

The Authority considered the recommendation of SEAC, the submissions made by the project proponent and approved the proposal for Environmental Clearance.

- 3. Application for Environmental Clearance for the proposed river bed sand mining project from River Mahananda at J.L. No. 10, Plot nos. 36 P, Vill - Paschim Dangapara, PO. & PS. Chopra, Dist. Uttar Dinajpur, West Bengal by Sudipta Bose.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

- 4. Application for Environmental Clearance for the proposed river bed sand mining project from River Mahananda at J.L. No. 001, Plot nos. 123, 124, 125, 126, 127, 128(P), 129,130, 131, 132, 133, 134(P), 137(P), 8401(P) & 8404, Vill - Chittal Ghata, PO. & PS. Chopra, Dist. Uttar Dinajpur by Md. Sefiul.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

II. Stipulated Conditions

- 1. Application for Environmental Clearance for the proposed residential cum commercial complex at Dag No. 199, 205, 218, 227, 232-236, 248-254, Khatian no. 1276, 1274, 1537-1549, 1581, 1824, 1825, 1844, 1863, 1892-1894, 1899-1902, 2293, 2311, 2452, Mouza - Atghara, J.L. No. 10, Biswa Bangla Sarani, Chinar Park, Kolkata - 700 136, Ward No. 12, Bidhannagar Municipal Corporation, P.O. Rajarhat Gopalpur, P.S. Baguihati, Dist North 24 Parganas, West Bengal by M/s. Ambey Realtors LLP.**

SEIAA examined the documents submitted by the project proponent. It is found that the detailed plan and sectional drawings of the STP, compost plant and rainwater harvesting reservoir are not in order and need to be submitted after incorporating the necessary details which are as follows:

- i) Plan showing and mentioning the position and dimensions of STP, compost plant, rainwater harvesting reservoir in a scaled drawing.
- ii) Sections showing the levels of the STP, compost plant, rainwater harvesting reservoir in connection with the building (if attached) or the site (if detached) along with other facilities, if any.
- iii) Plan and section showing access to the utilities as mentioned above.

III. Miscellaneous

1. **Amendment & Extension of Validity – Application for Environmental Clearance for proposed “Calcutta Riverside Township” project at Batanagar, Maheshtala Municipality, Dist. – 24 Parganas (South) by M/s. Riverbank Developers Pvt. Ltd.**

The Authority examined the submission of the project proponent and decided to refer the case to SEAC for necessary appraisal.

2. **Amendment – Application for Environmental Clearance for the Proposed residential complex at J.L. No. 74, Mouza –Digberia, P.S. Madhyamgram and J.L. No. 42, Mouza – Kutulsahi, P.S. Barasat, Badu Road, Dist. North 24 Parganas, West Bengal by M/s. Swadha Nirman Pvt. Ltd. and Others.**


The Authority examined the submission of the project proponent and decided to refer the case to SEAC for necessary appraisal.
